FOR THE USE OF PROPERTY BELONGING TO
FIRST BAPTIST CHURCH, BROWNSVILLE, TEXAS**

I ACKNOWLEDGE THE HAZARDS AND RISKS OF THE USE OF HENDRICK MISSION CENTER WHICH IS OWNED BY FIRST BAPTIST CHURCH, BROWNSVILLE, TEXAS AND I WISH TO ASSUME ALL LIABILITY. I AM RESPONSIBLE FOR CHILDREN ACCOMPANYING ME. AS USED IN THIS RELEASE, THE TERMS, I, ME, THE UNDERSIGNED AND MYSELF INCLUDE MINORS AND OTHERS IN MY CARE WHILE ON THESE LEASED PREMISES.

I hereby acknowledge that I have knowingly and willingly agreed to use the Hendrick Mission Center and further acknowledge and understand that NO WARRANTY, EITHER EXPRESS OR IMPLIED, is made by First Baptist Church, Brownsville, Texas or anyone else as to the condition of the property, real and/or personal or any roads, buildings, fences, gates or other improvements or facilities located on the property. By executing this Release of Liability and Acknowledgment and Acceptance of Dangers, Risks, and Hazards of property belonging to First Baptist Church, Brownsville, Texas, the undersigned hereby expressly acknowledges and agrees that this document constitutes sufficient warning that dangerous conditions, risks and hazards do exist on the property and the undersigned's presence and activities on the property expose both me and my property to dangerous conditions, risks and hazards, including, but not limited to the dangers associated with the mission property and facilities, whether or not the facilities were constructed or maintained by First Baptist Church, Brownsville, Texas, the general condition of the land and dangerous driving or walking conditions. I hereby state that I expressly assume all known and unknown dangers, risks and hazards.

FOR THE GOOD AND VALUABLE CONSIDERATION OF THE OPPORTUNITY TO STAY AND/OR EAT AT HENDRICK MISSION CENTER, I HEREBY RELEASE AND AGREE TO DEFEND, INDEMNIFY AND HOLD HARMLESS FIRST BAPTIST CHURCH, BROWNSVILLE, TEXAS, INCLUDING, WITHOUT LIMITATION, ANY VOLUNTEER WHO IS ASSISTING FIRST BAPTIST CHURCH, BROWNSVILLE, TEXAS AND ALL OTHER PERSONS AND EACH OF THE FOREGOING RESPECTIVE AGENTS OF THOSE PARTIES INCLUSIVE, BEING HEREIN COLLECTIVELY CALLED THE "INDEMNIFIED PARTIES" FROM AND AGAINST ANY AND ALL CLAIMS, DEMANDS, CAUSES OF ACTION, LOSSES, LIABILITIES AND DAMAGES, INCLUDING ATTORNEY'S FEES AND COURT COSTS, RESULTING FROM MY STAY AT HENRICK MISSION CENTER OR ANY FACTS OR CIRCUMSTANCES, ACCIDENT, INCIDENT OR OCCURRENCE ARISING OUT OF, INCIDENTAL TO OR IN ANY WAY RESULTING FROM THE USE OF THE PROPERTY AND ALL IMPROVEMENTS THEREON BY THE UNDERSIGNED, WHETHER OR NOT CAUSED BY THE NEGLIGENCE OR GROSS NEGLIGENCE OF ANY ONE OR MORE OF THE INDEMNIFIED PARTIES. I HEREBY FURTHER COVENANT AND AGREE THAT I, AND ON BEHALF OF MYSELF AND MY ESTATE, COVENANT THAT MY HEIRS, SUCCESSORS AND ASSIGNS, WILL NOT MAKE ANY CLAIM OR INSTITUTE ANY SUIT OR ACTION, AT LAW OR IN EQUITY AGAINST ANY OF THE INDEMNIFIED PARTIES ON MY BEHALF, FOR OTHERS OR FOR THE MINORS UNDER MY SUPERVISION.

THE UNDERSIGNED FURTHER ACKNOWLEDGES THAT NONE OF THE INDEMNIFIED PARTIES HAVE MADE ANY WARRANTIES OR REPRESENTATIONS, EXPRESS OR IMPLIED, IN REGARD TO FIRST BAPTIST CHURCH, BROWNSVILLE, TEXAS OR HENRICK MISSION CENTER AND THE UNDERSIGNED HEREBY SPECIFICALLY DISCLAIMS AND WAIVES ANY AND ALL WARRANTIES AND REPRESENTATIONS, EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO ANY IMPLIED WARRANTIES OF HABITABILITY OF FITNESS FOR A PARTICULAR PURPOSE IN REGARD TO THE CONDITION OF THE PROPERTY.
